

**PARENT / GUARDIAN CONSENT FORM (08)**

The West Windsor-Plainsboro Regional School District traditionally publishes student names in local media and on the district web site. **Additionally, the Broadcasting Program has its own web sites, including for the radio station and for the teacher of the program.** In addition, photographs can be included with press releases sent to local newspapers and displayed at various functions and on bulletin boards. While the intent of this practice is to be informative, there is concern about the individual right to privacy.

This consent form has been prepared to inform you and to request permission for your child's name and photograph/image to be published on the district's web site, on the Broadcasting Program's web sites, and to be sent to local media for various school -related activities, including but not limited to: awards, special programs, scholarships, community service activities, athletic events, program playbills and involvement in broadcasting activities, programs and productions (radio, cable television, internet, etc.)

As you are aware, there are potential dangers associated with the posting of personally identifiable information on a web site since global access to the Internet does not allow us to control who may access such information. These dangers have always existed; however as your school district, we do want to celebrate your child's work and accomplishments. The law requires that we ask for your permission to use information about your child.

Pursuant to the law, we will not release any personally identifiable information without prior written consent from you as a parent or guardian. Personally identifiable information includes student name, photograph or images, school locations and class trip information.

*If you, as a parent or guardian, wish to rescind this agreement, you may do so at any time in writing, by sending a letter to Mr. Allison and /or the principal or your child's school, and such rescission will take effect upon receipt by the school. Otherwise, this permission slip will apply indefinitely.*
